

of Steven Petrow's Complete Gay & Lesbian Manners and The Lost Hamptons. He's a much sought-after public

networks. He's a past president of NLGJA: The Association of LGBTQ Journalists and a current board member at
the Virginia Center for the Creative Arts. Steven is also the 2024 North Carolina Piedmont Laureate and lives in

Paul Greenwood



Paul Greenwood is a former Elder Abuse Career Prosecutor, Deputy District Attorney in San Diego, and is now owner of Greenwood Law Corporation.

Having practiced law for more than 40 years, he has in-depth experience in elder abuse felony criminal prosecution, public speaking, legal writing, jury trials, assisting with drafting legislation, and community advocacy. His diverse legal education includes Gray's Inn, one of the historic societies that educate and train barristers in England and Wales, University of Law Guildford, and University of Leeds – all in the UK.

As a member of the State Bar of California, California Lawyer magazine named Paul as one of their top 20 attorneys of the year in 1999. He is currently a criminal justice at large board member of the National Adult Protective Services Association and has testified before the US Senate Committee on Aging. He has presented many keynotes for national and international organizations in the USA, Canada, Singapore, and UK. And he has been designated as an expert witness regarding red flags of undue influence by which a perpetrator has exploited an older or dependent adult.

In March 2018, Paul retired from the San Diego DA's office to concentrate on sharing lessons learned from his elder abuse prosecutions with a wider audience. Later that year, he was presented with the Edwin Miller Jr. Lifetime Achievement Award by the San Diego Deputy District Attorneys Association. Paul now spends much of his post-retirement time speaking on behalf of the AARP, consulting on elder abuse cases, and providing training to law enforcement and Adult Protective Services agencies across the country and internationally. Paul is also a current member of Aging Today Editorial Advisory Committee and serves on the National Center on Elder Abuse Advisory Board.

<u>Super Star</u> - Honors an employee for the quality of direct service they provide to older adults in their community. Candidates must be front line services delivery workers.

<u>Guiding Star</u> - Honors a supervisor or manager for quality supervisory skills in the management of programs and staff they provide that benefit older adults. This award recognizes their ability to supervise and motivate staff as they provide quality work in their community.

<u>Rising Star</u> - Honors a rising star employee with three or fewer years of work experience in the aging network. This award recognizes their ability to take on leadership roles and an interest in the future of their organization and the field of aging.

<u>Rock Star</u> - Honors a Chief Executive/Administrative Officer for the quality of leadership and organizational management they provide to their organization and to the aging network. Candidates must have significant year (candidate is preferred have 5 plus years of work experience) as a Chief Executive or Administrative Officer with their organization.

<u>Reaching for the Stars</u> - Honors an agency or organization that has an innovative and creative program that is working to enrich the lives of older adults. We are looking for programs that are creative and effective in enhancing the lives of older adults.
